

## **Appendix**

### Data protection - general information on the handling of your data

We attach great importance to the conscientious handling and protection of your personal data. We therefore inform you in detail below about how we handle your data. Please read this privacy policy carefully.

Your personal data is collected and processed on the basis of Article 6 para. 1 - 3, Article 9 para. 2 - 3 GDPR and §§ 5, 6 of the German Federal Data Protection Act (BDSG) as well as special legal provisions in order to process the request submitted by you.

The personal data provided by you in this expression of interest is required for the purpose of processing your expression of interest and for further communication between you and the institution of the FAWZ gGmbH involved in the international school exchange. Without this information, the expression of interest cannot be processed at FAWZ gGmbH & its private institutions.

#### Fundamental rights of the data subjects with regard to the processing of personal data

According to the GDPR, every person affected by data processing has in particular the following rights:

- ▶ The right to information or the right to inspect files concerning the data stored about you & its processing (Article 15 GDPR).
- ▶ The right to rectification of data if your data is inaccurate or incomplete (Article 16 GDPR).
- ▶ The right to erasure of the data stored about you, provided that one of the conditions of Article 17 GDPR applies.
- ▶ The right to restriction of data processing under Article 18 of the GDPR.
- ► The right to data portability (Article 20 GDPR).
- ▶ The right to object to certain data processing, provided there is no compelling public interest in the processing which overrides the interests of the data subject and there is no legal obligation to process (Article 21 GDPR).

The legislator has determined various retention obligations and periods. After expiry of these periods, the corresponding data is routinely deleted or destroyed in compliance with data protection if it is no longer required for the fulfilment of tasks.

Each data subject has the right to lodge a complaint with the company data protection officer of FAWZ gGmbH or the state data protection officer if they believe that their personal data has been processed unlawfully.
